## GPS Requirements Part 1: GPS "ALWAYS ALLOW" and "PRECISE"

Apple and Android need permission to access the GPS location "always."

Solution: Reps should be trained to use "Always Allow"

\*Note that TeleMapper only submits GPS data when a rep has checked into a location and is on the clock. Meal breaks and post-check-out are not recorded or submitted.

About every three days, Apple devices will confirm whether an end user wants to continue to use an app with "Always Allow" GPS. Reps should click "Always Allow" when they see this screen.

## GPS Requirements Part 2: Stay Charged & Allow Battery

Start the day with a **full charge** and keep it charged wherever possible. Your phone will put apps to sleep when your battery gets critically low (on most phones when below about 20%).


- Apple Devices:
  - Disable "Low Power Mode"
  - Enable Background App Refresh

#### Android Devices:

- Disable "Battery Saver"
- Disable "Extreme Battery Saver"
- Disable "Adaptive Battery"








## GPS Requirements Part 3: Use WiFi if Available

Some stores have a weak carrier signal and a weak GPS signal.

Use store WiFi if available to supplement the internet connection and improve your GPS location. Work with your TMM as necessary to address problematic stores.






## GPS Requirements Part 4: Within 500-800 Feet of the Center of the Store

Reps should be in the footprint of the (checked-in) store.



## GPS Requirements Part 5: Leave TeleMapper OPEN and the phone ON

Closing TeleMapper is akin to "killing" it – just like any other app, it will not be able to report its location every 5 minutes.

Solution: Reps should leave the app "open" on their phone. It can be in the background if they need to switch to a different app, make a call, send a text, etc. – but they need to leave TeleMapper RUNNING.

Leave TeleMapper Running. Do Not "Swipe Up" on TeleMapper during workday




## GPS Requirements Part 6: Prevent Hibernation

Hibernation: sometimes a phone will simply put an app to sleep (usually after 2-4 hours of non-use) to try and help save battery life.

Solution: Reps should revisit TeleMapper from time to time to train their phone to keep the app awake. If you would like to leverage activity data, you can ask your team to use the "Tally" feature in TeleMapper to submit their talked to / pitches / sales – this will keep the app awake and train their phone to prioritize TeleMapper.

This data will help create reports around store traffic, average customers / sale / rep, etc. – and it will help keep GPS pings coming.




## Alerting System (launching with this new ECB Bonus requirement)

Sometimes reps are busy or forget their training. eStream is releasing a rep-alerting system that will send text messages, emails and / or "push notifications" (set by ICD) to any rep whose phone has not successfully sent a ping in 30-50 minutes (set by ICD).

It takes about 7 seconds to unlock your phone and submit a ping.


Prompting ICD / admin to check rep status

#### Notifications Settings

You can set TeleMapper to send notifications whenever a rep's phone stops sending its GPS location within the store location (currently set to 800 Feet). Select the amount of time after which a notification should be sent. Sales Rep alerts go out to individual reps after the specified amount of non-ping time. ICD alerts will go to the ICD Owner (and / or any additional contacts you specify) 10 minutes later. "Rep Alerts" are for an individual rep. "Store Alerts" are for a lack of GPS location pings for an entire store and program. SMS credits will be deducted from your ApplicantStream SMS balance - which can be viewed in ApplicantStream (Be sure and keep enough SMS credits in your balance). Standard SMS costs, if any, will apply to all recipients based on the recipient's SMS plan. TeleMapper relies on third-party delivery services, cellular carriers and email providers for timely delivery of messaging (SMS, Push Notifications and Emails) - TeleMapper and eStream are not responsible for on-time delivery of messages. ICD Owners are ultimately responsible for store staffing and monitoring.
